



WEBBERS Legends of Stance Competition – Terms and Conditions

1. Competition Duration

- 1.1 The WEBBERS Legends of Stance Competition (“the Competition”) will run from Friday, **28 November 2025** to Wednesday, **31 December 2025**, both dates inclusive.
- 1.2 Entries received outside of this period will not be considered.

2. Eligibility

- 2.1 The Competition is open to all customers who make a qualifying purchase of **R499.00** (Four Hundred and Ninety-Nine Rand) or more at participating Webbers stores during the competition period.
- 2.2 Only cash sales qualify for entry.
- 2.3 Lay-buys or lay-by purchases are not eligible for entry.
- 2.4 Competition entry slips submitted in respect of returned goods or refunded sales will be considered null and void and will not be accepted as valid entries into the competition.
- 2.5 Customers must be 18 years or older, with a verifiable South African Bank account, to be eligible to claim the prize.
- 2.6 Employees, directors, agents, and contractors of Saville Row (Pty) Ltd t/a Webbers, as well as their immediate family members, are not eligible to enter the competition.

3. How to Enter

- 3.1 Each qualifying purchase of **R499** shall entitle the customer to one (1) manual entry into the competition.

3.2 Entries are cumulative. For every R499 spent, one (1) entry will be awarded. For example, a spend of R499 will generate one (1) entry, R998 will generate two (2) entries, R1 497 will generate three (3) entries, and so on.

3.3 To enter, the customer must manually submit the competition entry portion found at the bottom of the original till slip into the designated in-store competition entry box.

3.4 The following information must be clearly written on the competition entry form:

Cell phone Number

3.5 The customer must retain their original purchase slip for verification purposes.

3.6 Any till slip entry portion drawn without the above contact details, incorrect -, or unreachable contact details, will be declared invalid, and a redraw will take place.

4. Prizes and Winners

4.1 The first ten (10) valid till slips drawn will each win:

R25,000.00 (Twenty-Five Thousand Rand) cash prize, and

One (1) Legends-branded bicycle.

5.1 Winners will be contacted telephonically and by email using the contact details provided on the entry slip.

5.2 Payment of prize money will be made by Electronic Funds Transfer (EFT) into the registered or nominated South African bank account of each winner. Webbers will not request banking details via SMS or WhatsApp, only through official email channels.

5.3 Prizes are non-transferable and may not be ceded, exchanged, or substituted for cash or any other item.

5.4 The Legends-branded bicycle will be handed over at the Webbers store where the qualifying sale was made.

6. General Terms

6.1 By entering this competition, participants confirm that they have read, understood, and agree to be bound by these Terms and Conditions.

6.2 Entry into the competition is free once the qualifying purchase is made.

6.3 All till entry slips become the property of Saville Row (Pty) Ltd upon entry.

6.4 Saville Row (Pty) Ltd reserves the right to amend, modify, or update these Terms and Conditions at any time, in line with applicable laws or operational requirements, provided that such amendment will not materially prejudice any participant who has already entered.
